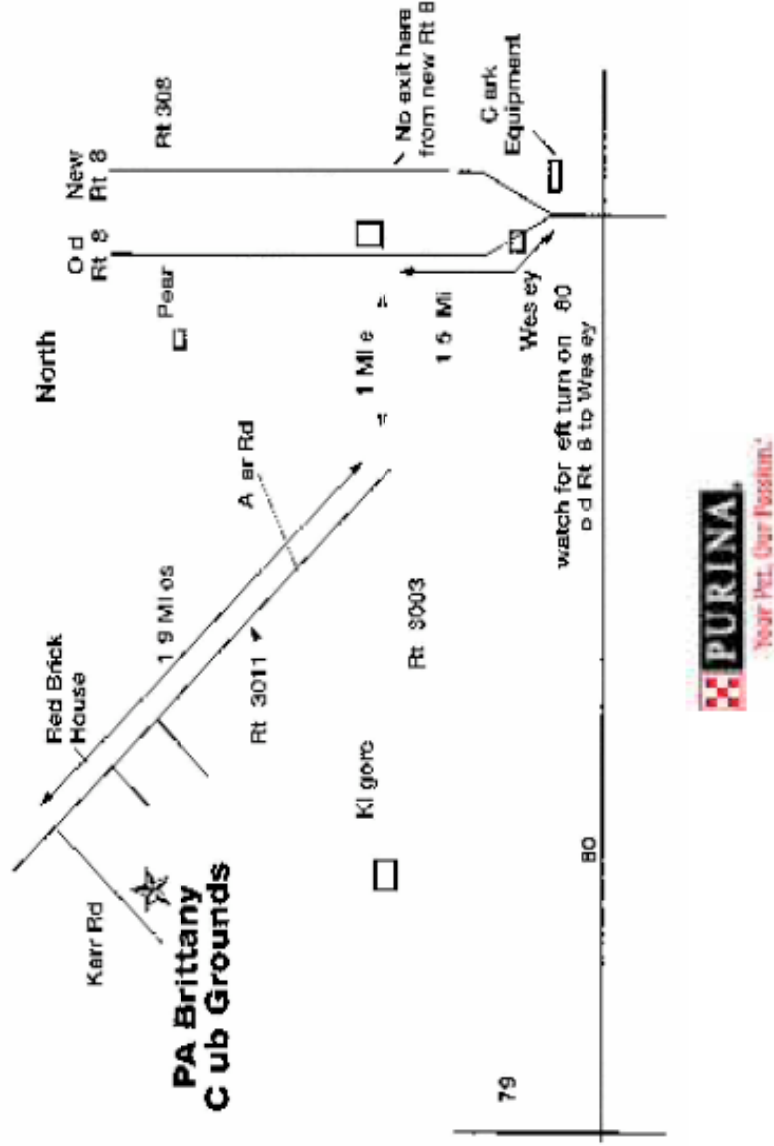

DIRECTIONS

I-80 TO ROUTE 8, BARKEYVILLE EXIT. GO NORTH 1 MILE ON RT. 8, THEN MAKE A LEFT ONTO OLD ROUTE 8, TOWARD WESLEY. GO 1.5 MILES, THROUGH WESLEY, TO SR 3003, TURN LEFT (WEST) AND GO 1 MILE TO RT 3011 AND TURN RIGHT. GO 1.9 MILES TO KERR ROAD ON LEFT. (the rd. name sign may be gone, it is a T intersection and there is a brick farm house on the rt. just before you get to Kerr Rd.) FOLLOW KERR RD. TO GROUNDS ON LEFT. 256 KERR ROAD.
